

SMUD Multifamily Program Measure Requirements

Refer to SMUD Multifamily Handbook for additional program participation requirements.

All multifamily properties must have at least 5 contiguous units.

All properties participating in the Multifamily Program must work with SMUD's Tenant Engagement team, but only qualifying properties may include the equity assistance.
