Authorize the Chief Executive Officer and General Manager to award contracts to **Clark Bros, Doug Veerkamp General Engineering**, and **Syblon Reid** to provide time and material construction services at SMUD's **Upper American River Project (UARP)** for a three-year period from approximately September 1, 2019, to August 31, 2022, with three optional one-year extensions for each contract, for a total aggregate amount not-to-exceed \$15 million.
2. Authorize the Chief Executive Officer and General Manager to award a contract to **Drill Tech Drilling and Shoring, Inc.** to provide bolt augmentation service at SMUD's **Upper American River Project (UARP) White Rock Tunnel** for a two-year period from approximately August 19, 2019, to August 18, 2021, in an amount not-to-exceed \$17,542,088.
