

Business Need

These Construction Services Contracts are needed to:

- Construct distribution substations
- Construct new reinforced concrete foundations
- Install conduit duct banks
- Perform structural repairs
- Install or modify electrical grounding systems, fencing, and manhole access grates
- Place aggregate base and crushed rock
- Grading and paving
- Construct electric vehicle charging stations





Procurement Strategy

Proposals were solicited by an RFP to allow SMUD to award contracts on a best value basis.

Themes evaluated

- SEED Participation
- Proposer's Company Experience and Qualifications
- Proposers Experience and Qualifications of Key Project Personnel
- Technical Approach
- Proposer's Safety and Environmental
- Commercial Terms (Price) and Compliance with SMUD's Contractual Terms

Procurement notified 34 contractors, received interest from 17, 9 attended the pre-proposal conference, and 8 submitted a proposal.



Award Strategy

Multiple zero-dollar contract awards

- Mitigate labor resource risks by providing more than one supplier/contract
