The purpose of the meeting will be to review, discuss, and provide the Committee's recommendation on the following item(s):

DISCUSSION ITEMS

- 1. Authorize the Chief Executive Officer and General Manager to award a contract to **Granite Construction Company** to provide construction services for the **Union Valley Bike Trail Extension Project** in the Crystal Basin region of the **Upper American River Project (UARP)** for a total contract amount not-to-exceed \$20,300,300 and for a contract term from May 1, 2021, to December 31, 2023.
- 2. Authorize the Chief Executive Officer and General Manager to award contracts to **Sierra National Construction, Inc., Arrow Construction,** and **Mountain G Enterprises** for civil construction services for a contract term of three years from April 19, 2021, to April 18, 2024, for a total aggregate contract amount not-to-exceed \$35 million.
- 3. Authorize the Chief Executive Officer and General Manager to award contracts to Arrow Construction and Teichert Energy & Utilities Group, Inc. for urban civil construction services in Downtown Sacramento for a contract term of three years from April 19, 2021, to April 18, 2024, for a total aggregate contract amount notto-exceed \$30 million.
