Authorize the Chief Executive Officer and General Manager to award a contract to **Doug Veerkamp General Engineering, Inc.** to provide construction services for the **West Point and Yellowjacket Campgrounds and Appurtenant Boat Ramps Project** in the Crystal Basin region of the **Upper American River Project (UARP)** for a total contract amount not-to-exceed \$8,396,902, and for a contract term from April 1, 2021, to January 31, 2022.
- 7. Authorize the Chief Executive Officer and General Manager to execute a fouryear Customer-Tailored Electric Services Agreement with NTT Global Data Centers Americas, Inc. (NTT).
