

### **Cordova Park Project Overview**







# **Project Description**

- Replace 12kV and 69kV underground cable
  - Abandon existing cable in place
- Project elements include:
  - Phase 1
    - Up to 3,000 feet of underground 12kV cable replacement in Ambassador Drive.
    - Open trenching and placed within conduit.
    - Construction anticipated to begin between August and September 2022
  - Phase 2
    - Approximately 2 miles of underground 69kV cable replacement
    - Up to 13 utility vaults
    - Construction anticipated to occur within the next 5 to 8 years





# Public Review Process – Notice of Preparation (NOP) and Draft Environmental Impact Report (EIR)

- Published at SMUD.org, Sacramento Bee
- Draft EIR 45-day public comment period (5/11/22 6/27/22)
- Mailed to landowners within 500 feet of the project site; Native American Tribes; Local Agencies
- Available at Customer Service Center, East Campus Operations Center
- Public Meetings
  - Scoping Meeting (3/24/22)
  - Draft EIR Public Meeting (6/9/22)

The Project will implement 12 mitigation measures that will reduce all potentially significant impact to a less-than-significant level.



# AB 52, Tribal Consultation

- Eight AB-52 consultation meetings with the Tribes
- Canine Forensic Surveying per recommendation from United Auburn Indian Community (UAIC)
  - UAIC and Wilton Rancheria monitors attended the survey
  - 3 distinct locations were identified
- Tribes reviewed both the cultural resource and Tribal cultural resource EIR chapters before publication and staff was able to incorporate all comments and recommendations.
- Subsequently, the Tribes did not comment on the Draft EIR or attend the public meetings.





### **SMUD Board Alternatives**

- Certify the EIR for the Cordova Park Underground Cable Replacement project, adopt the Findings, adopt the Mitigation Monitoring and Reporting Program, and approve the project.
- Return to staff for further study.
- Reject the proposal and CEQA analysis.
