## Background - Claims Administration Services

SMUD is self-insured for Workers Compensation, Short-Term Disability (STD) and Long-Term Disability (LTD) Programs, providing benefits to employees that are injured on the job and partial salary replacement for those unable to work due to non-work-related illness or injury

#### **Intercare Holdings**

2013 solicitation (RFP) with nine proposers

- Intercare was the highest technical rated proposer (10% higher than all others)
- Awarded contract

2017 solicitation (RFP) with three proposers

- Intercare was the highest rated proposer by 20%
- Modified program to be able to administer STD/LTD programs for SMUD



### Contract Extension Allows

Maintain continuity of programs while SMUD's People Services & Strategies (PS&S) department explores options to enhance STD/LTD benefits to continue to support our diverse workforce. Analysis to include:

- Plan designs
- Benchmarking
- Employee contributions
- Additional offerings (paid family leave)
- Financials
- Launch RFP for services needed based on completed analysis



## **Pricing Environment**

- Current monthly rate
  - \$30,840.75 per month
- Proposed rates
  - Year 1 \$32,471.07 per month
  - Year 2 \$33,607.56 per month
- Rates proposed are in line with contracted escalation of 3% which is significantly lower than the current inflation rate of approximately 9% per Consumer Price Index for All Urban Consumers
