

# **Procurement Strategy**

- Proposals were solicited by an RFP to allow SMUD to award contracts on a best value basis.
- Themes evaluated
  - Mandatory Requirements
  - SEED Participation
  - Safety and Environmental Sustainability
  - Proposer's Experience and Qualifications
  - Experience and Qualifications of Key Project Personnel
  - Proposer's Ability to Respond to SMUD's Needs
  - Technical Approach
  - Commercial Terms (Price) and Compliance with SMUD's Contractual Terms
- SMUD staff notified 1715 companies and 57 of those companies viewed the opportunity. Of the 57 that viewed the solicitation, 8 were interested in bidding.
