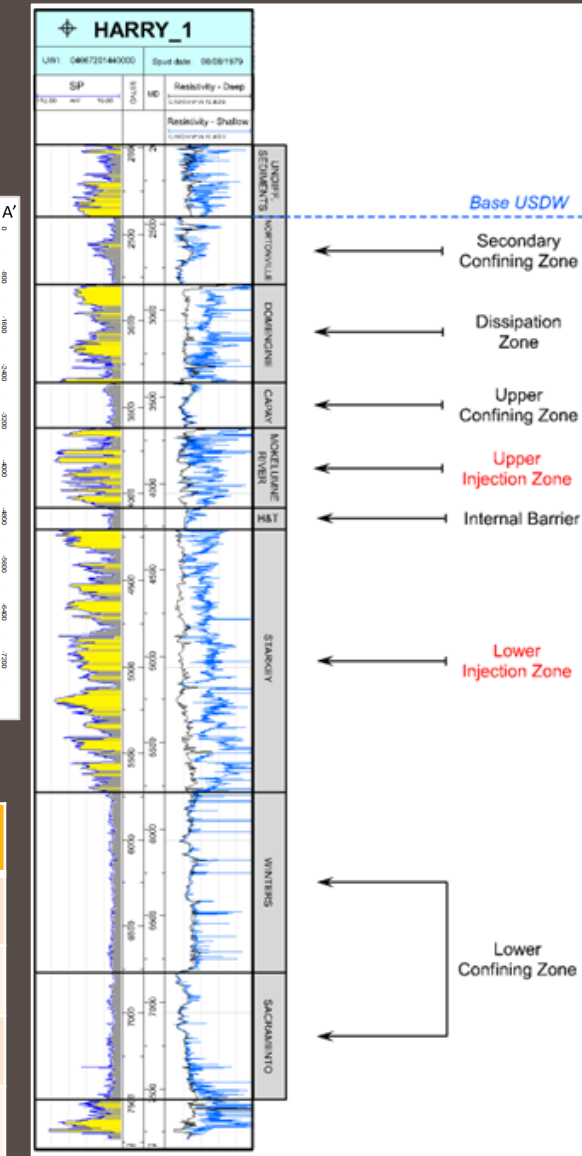
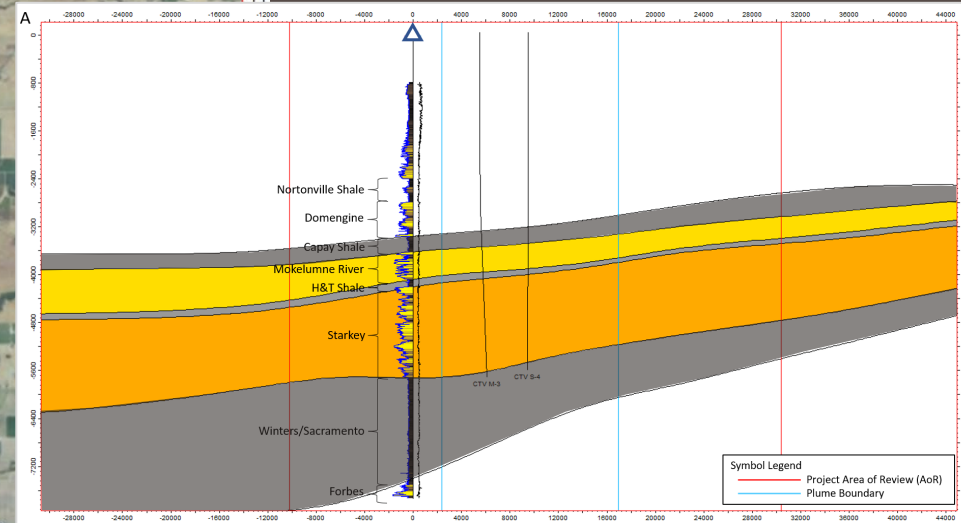
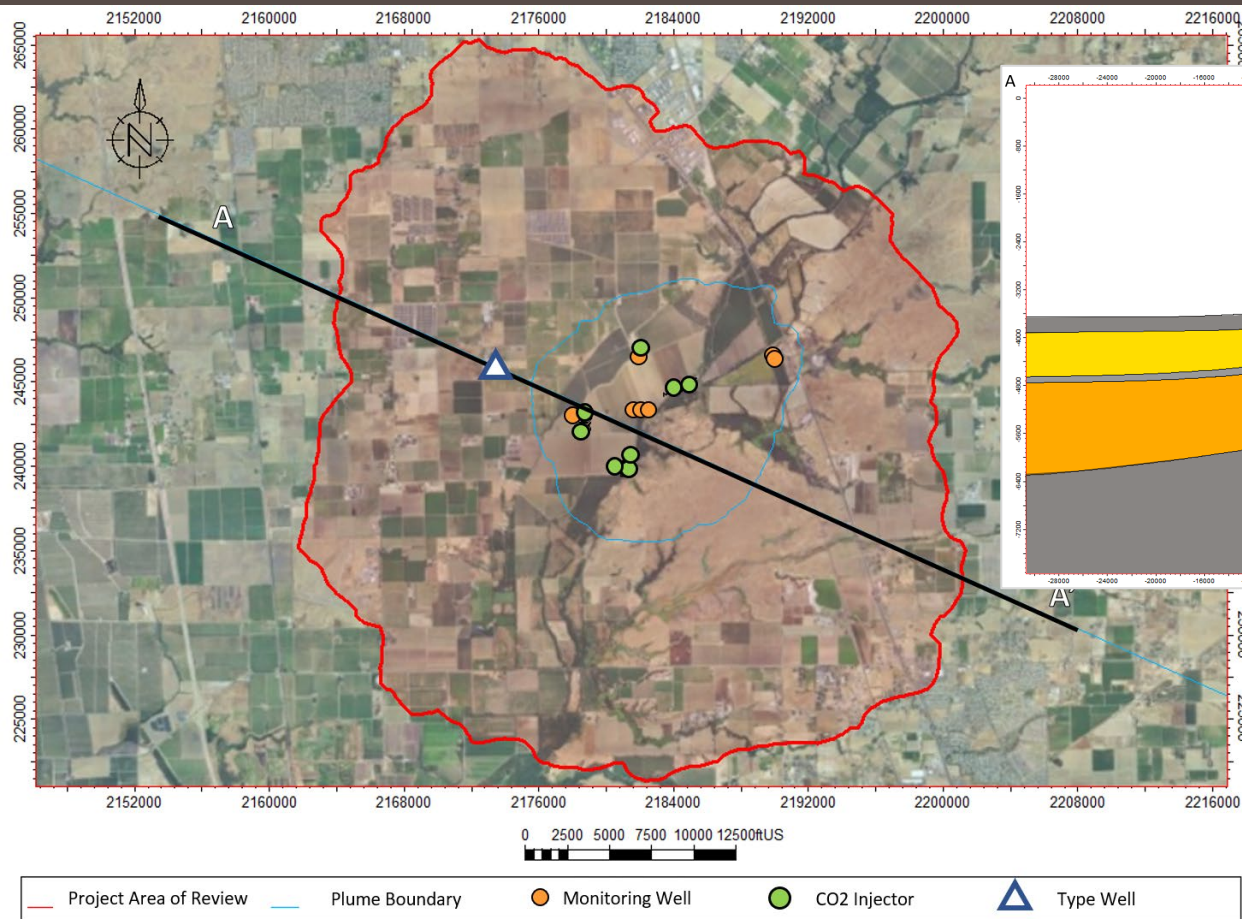
California's Premier Carbon Management Provider

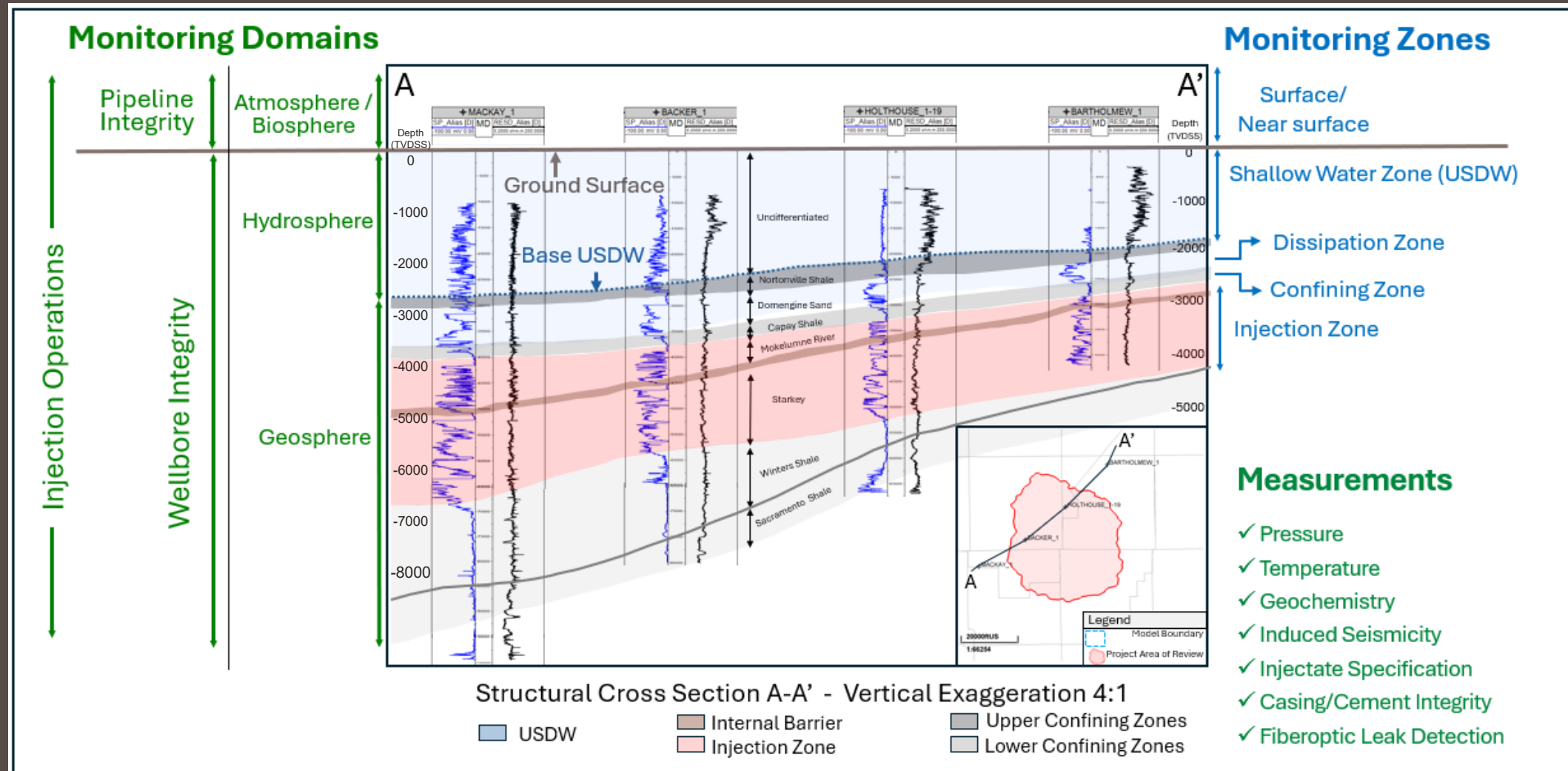

Land Use Permitting

Only two counties in CA have Zoning Ordinance that address CCS

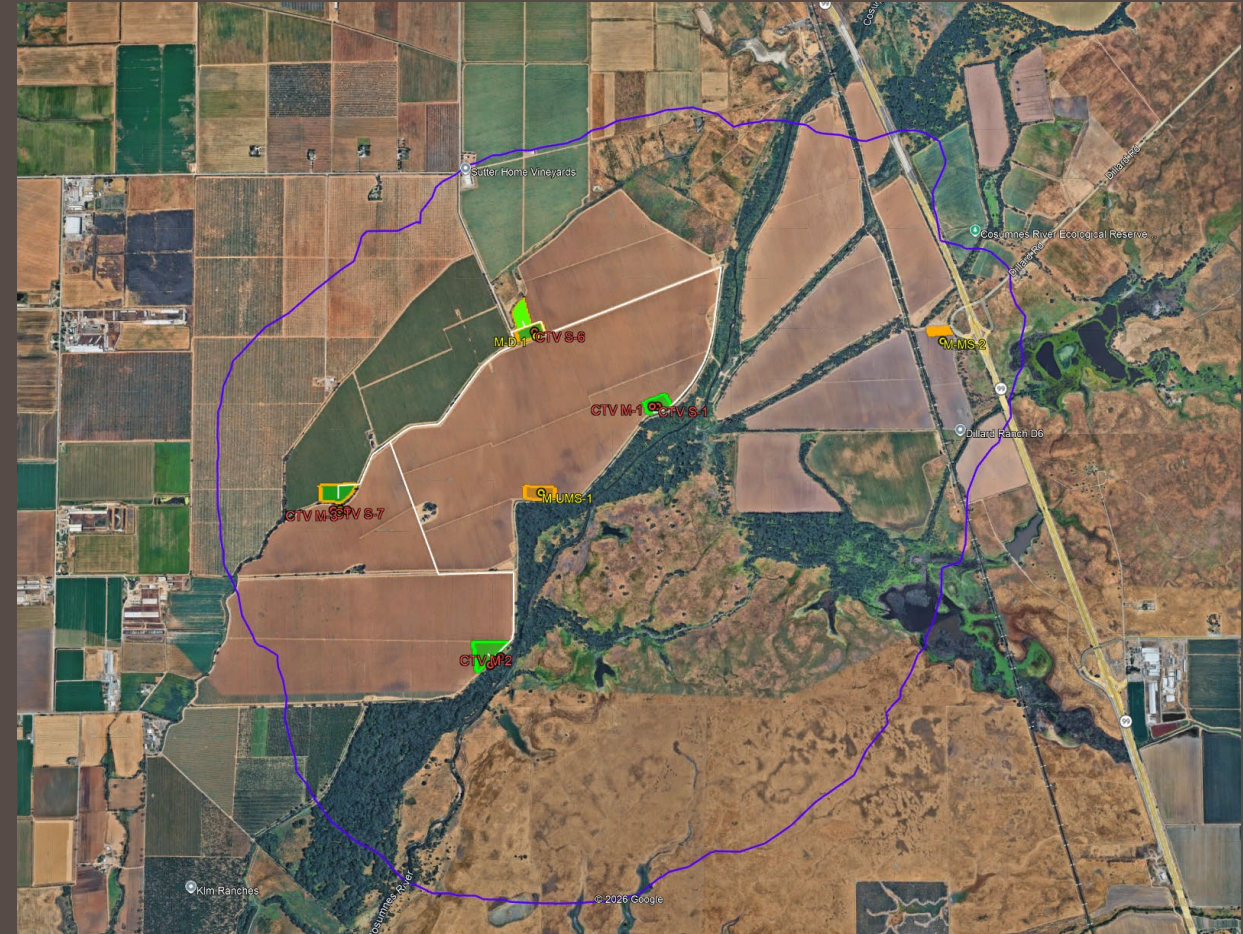
- Both require a Conditional Use Permit (CUP) for all CCS operations
- Specifies three planning zones where CCS is allowed
 - “A”, “M-2”, and “M-3”

CUP requires compliance with CEQA

- Mandatory Environmental Impact Report (EIR)
- Certified by County Board of Supervisors

SB 905 will not create a one-stop shop for CCS permitting

- Intended to be a coordinated application and information-management system
 - Reduce duplicative application questions
 - Encourage coordination among permitting agencies



Community Engagement



- Some regulatory paths require Community Engagement
