

**OFFICIAL RULES – Making Life Easier Sweepstakes**  
**NO PURCHASE NECESSARY TO ENTER OR WIN**

**General Rules:** The name of the promotion governed by these Official Rules is the SMUD Making Life Easier Sweepstakes (“Sweepstakes”). The Sweepstakes begins **May 29, 2019** and ends on **September 10, 2019** at 11:59 PM Pacific Time. There will be two drawings for two identical prize bundles, one for enrollments May 29, 2019 through July 31, 2019 and one for August 1, 2019 through September 10, 2019.

**Eligibility:** Sweepstakes open to residents of the Sacramento Municipal Utility District (“SMUD”) service area and SMUD customers. All entrants must be eighteen (18) years of age or older. Not open to employees and immediate family members (spouse, parent, siblings and children) of SMUD, its directors, officers, employees or agents.

**Indemnity:** By entering, entrant agrees to be bound by these Official Rules and hold harmless and indemnifies SMUD and each of its directors, officers, employees, or agents against any and all liability, damages or causes of action (however named or described), with respect to or arising from either the entrant’s participation or the receipt or use of the prizes awarded in this Sweepstakes.

**How to Enter:** To enter, entrant must enroll in Paperless Billing through smud.org. By enrolling in SMUD’s Paperless Billing program, the entrant automatically enters the Sweepstakes and confirms that he/she agrees to all official rules. **Those not enrolling in SMUD’s Paperless Billing** may enter by mailing a 3.5” x 5” postcard to the address below (hand print your name, age, address with zip code, daytime and evening telephone numbers, and e-mail address). **Mail postcard entries by September 10, 2019 to: SMUD Making Life Easier Campaign, c/o SMUD, P.O. Box 15830 – M.S. A104, Sacramento, CA 95852-1830.** Limit one (1) entry/postcard per household. SMUD is not responsible for lost, late, incomplete, inaccurate, stolen, delayed, undelivered, illegible, or improperly inputted entries.

**Entry Deadline:** For the first drawing, SMUD customers must enroll in Paperless Billing between May 29, 2019 and **July 31, 2019** by 11:59 PM Pacific Time. For the second drawing, SMUD customers must enroll in Paperless Billing between August 1, 2019 and **September 10, 2019** by 11:59 PM Pacific Time.

**Random Drawing:** On or about **August 6, 2019**, and **September 17, 2019**, one (1) entry from the enrollment period of May 29, 2019 through July 31, 2019 and one (1) entry from the enrollment period of August 1, 2019 through September 10, 2019, respectively, will be drawn at random from all eligible entries received. The winner will receive a prize bundle containing multiple prizes. The drawing will be conducted by a representative or designee of SMUD, whose decision with respect to the selection of the potential winners shall be final. Entrants need not be present to win. The potential winners will be notified by direct message on or about **August 6, 2019**, and **September 17, 2019**. Odds of winning will depend upon the number of eligible entries received.

**Prize:** The prize bundle includes a \$50 promotional code to the SMUD Energy Store, a Nest Learning Thermostat, Google Home, Google Home Mini, a Phillips Hue A10 starter kit (white), and a Wemo mini smart plug. Product manufacturers are not sponsors of this Sweepstakes. Prize bundle must be picked up by the winner(s) at SMUD’s Customer Service Center, 6301 S Street, Sacramento, California 95817 by **August 31, 2019** for the winner who enrolled in the period of May 29, 2019 through July 31, 2019, and by **October 10, 2019** for the winner who enrolled in the period of August 1, 2019 through September 10, 2019. The retail value of the prize bundle is \$575. The prize bundle is non-transferable to any other person, including relatives and friends.
