SMUD Residential Charge Electric Incentive Application

Thank you for your application. This electric vehicle incentive offering is intended to encourage the adoption of new plug-in electric vehicles in the Sacramento area. This helps offset pollution from gas only vehicles and makes our community cleaner and healthier.

1. Read the Terms and Conditions listed below.
2. Ensure all information is correct, legible, and the SMUD customer of record signs the application. Provide mailing address (if different from service address). Incomplete applications will be returned to the SMUD customer.
3. Mail the completed and signed application package so that it is postmarked within 180 days (6 months) of the electric vehicle purchase/lease date.
4. Submit required documents in order to have incentive processed:
 - a. Completed and signed Residential Charge Free for Two Years EV Incentive Application
 - b. Copy of Auto Sales or Lease Contract
 - c. Copy of DMV vehicle registration. New vehicle dealer notice temporary identification (typically attached to windshield) is acceptable if it displays name and address of purchaser/lessee.

Important – Applicants are advised to retain a copy of this form and copies of all attachments submitted to SMUD for record keeping purposes. Documents for approved or ineligible applications will not be returned. Applicants requesting enrollment in the Time-of-Day (TOD) with EV discount rate will be enrolled if a plug-in EV is verified at residence even if this application is otherwise ineligible for the incentive. Please allow eight to twelve weeks to process and mail check or EV Charger.

Terms and Conditions

1. The incentives described in this application pertain to the purchase or lease of new plug-in electric vehicles only. Pre-owned vehicles are not eligible. The current dollar amount/description of the incentives are shown on the application. Incentive amount and type are subject to change at any time and may be greater or less than the current value posted in the application in the future. A qualified plug-in electric vehicle with a particular VIN can only be assigned one incentive in its lifetime, and only in the amount/type indicated on the application first submitted and approved; therefore, it is up to the applicant to determine when to apply for an incentive, however the complete application package must be postmarked within 180 days of date of purchase or lease to be considered.
2. The vehicle purchased/leased must be DMV registered at a residence with an active meter receiving SMUD electric service. Vehicle must be new plug-in electric vehicle, first time sale or lease.
3. SMUD expressly reserves the right to modify, amend or terminate the program, in whole or in part, at any time and for any reason without prior notice. Call 1-888-742-SMUD (7683) to obtain current rebate program information.
4. The complete incentive application package must be postmarked within 180-days of the date of EV purchase/lease to be eligible for incentive. An application package is considered complete only when **all** required documents clearly demonstrating eligibility is received by SMUD. If a complete application package, or any part thereof, is not postmarked within 180 days of purchase/lease date the application will be considered ineligible.
5. The incentive payment/delivery shall go directly to the customer of record (Incentive Payable/Delivered To) listed on the application to the mailing address listed on the SMUD account, or service address in the case of EV charger incentive shipment. Payment/Delivery cannot be assigned or transferred.
6. Customer agrees that SMUD reserves the right to request additional documentation prior to incentive payment/delivery. Incentive may be denied by SMUD if this condition is not met by customer.
7. **Disclaimer of Warranties:** SMUD makes no representations, expressed or implied, regarding the design, construction, reliability, efficiency, performance, operation, maintenance, or use of any vehicle, discussed, selected, rejected, purchased/leased or otherwise considered by customer. Any decisions regarding the selection, design, purchase/lease, use and operation of any vehicle shall be at the sole discretion and are the sole responsibility of the customer. SMUD does not guarantee energy or bill savings as a result of this rebate. SMUD makes no representations, expressed or implied, regarding the performance, operation, maintenance, or use of the EV Charger. All product warranties are supplied by the manufacturer/supplier and all defects will be processed and handled by the product supplier, as outlined in the warranty process.
8. **Customer/Purchaser shall indemnify,** defend, and hold harmless SMUD, its directors, officers, agents, and employees against all claims, loss, damage, expense, and liability asserted or incurred by other parties, including but not limited to SMUD's employees, agents, or suppliers arising out of or in any way connected with the EV Charger or incentive payment and caused by the acts, omissions, intent or negligence, whether active or passive, or customer, its agents, employees, and suppliers, and excepting only such loss, damage, or liability as may be caused by the intentional act or the sole negligence of SMUD.

NOTE: Incentive check or EV Charger will typically be mailed/shipped within 1-2 weeks subsequent to receiving all required documentation but could be longer depending on circumstances. EV Charger will be shipped directly to the customer listed on the application from SMUD's EV Charger Vendor. SMUD will supply to our EV Charger Vendor the name, service address, email address and phone number of customers who choose the EV Charger incentive for this purpose. Applications and incentives are processed on a first-come, first-served basis, and all incentives are subject to availability of funds.
