

OFFICIAL RULES

2019 Sacramento International Auto Show - Eric Church Ticket Sweepstakes NO PURCHASE NECESSARY TO ENTER OR WIN

1. **General Rules:** The name of the promotion governed by these Official Rules is the **2019 Sacramento International Auto Show - Eric Church Ticket Sweepstakes** ("Sweepstakes"). The Sweepstakes begins **October 18, 2019** and closes on **October 20, 2019** at 6:00 PM Pacific Time.
2. **Eligibility:** Sweepstakes open to residents of the Sacramento Municipal Utility District ("SMUD") service area and SMUD customers. All entrants must be eighteen (18) years of age or older. Not open to employees and immediate family members (spouse, parent, siblings and children) of SMUD, its directors, officers, employees or agents.
3. **Indemnity:** By entering, entrant agrees to be bound by these Official Rules and hold harmless and indemnifies SMUD and each of its directors, officers, employees, or agents against any and all liability, damages or causes of action (however named or described), with respect to or arising from either the entrant's participation or the receipt or use of the prizes awarded in this Sweepstakes.
4. **How to Enter:** To be automatically entered, entrant will take an electric vehicle test drive at the SMUD Ride and Drive at the Sacramento International Auto Show from October 18, 2019 through October 20, 2019. ***Those not attending the Sacramento International Auto Show*** may enter by mailing a 3.5" x 5" postcard to the address given below (hand print your name, age, address (including zip code), daytime and evening telephone numbers, and e-mail address. ***Mail postcard entries to: 2019 Sacramento International Auto Show - Eric Church Ticket Sweepstakes, c/o SMUD, P.O. Box 15830 – M.S. A203, Sacramento, CA 95852-1830.*** Limit one (1) entry/postcard per household. SMUD is not responsible for lost, late, incomplete, inaccurate, stolen, delayed, undelivered, illegible, or improperly inputted entries.
5. **Entry Deadline:** Entries must be received by **October 22, 2019** at 6:00 PM Pacific Time.
6. **Random Drawing:** On **November 1, 2019**, three (3) entries will be drawn at random from all eligible entries received. The drawing will be conducted by a representative or designee of SMUD, whose decision with respect to the selection of the potential winners shall be final. Entrants need not be present to win. The potential winner will be notified by telephone on or about **November 4, 2019**. Odds of winning will depend upon the number of eligible entries received.
7. **Prize:** The prize for each winning entry consists of two (2) tickets for Eric Church at the Golden 1 Center on November 22, 2019. The approximate retail value of the

prize is \$230. The winning prize is non-transferable to any other person, including relatives and friends. Winner is solely responsible for all applicable federal, state, and local taxes, and any expenses associated with the prize, unless otherwise specified. No substitution, cash equivalent or transfer of prize is permitted.
