While on public display, my Artwork may be photographed, videotaped or otherwise represented as part of the Custom Art Wrap Program and otherwise used for Applicant or SMUD for public information purposes (e.g., newspapers, newsletters, television, radio, internet, etc.).

4. Damage or Loss to Artwork May Occur. While Applicant will take reasonable care of my Artwork while displayed, Applicant and SMUD personnel participating in the Custom Art Wrap Program are not responsible for any damage or loss to the Artwork.

5. Voluntary Participation; No Expectation of Compensation. My participation in the Custom Art Wrap Program, including any additional use or disclosure permitted herein, is voluntary and without any expectation of compensation to me.

6. Revocation of Consent. This consent is effective unless and until I revoke it. I understand and agree that if anything containing my Artwork is printed, broadcast, or otherwise disseminated, it may be reprinted, rebroadcast or otherwise re-disseminated at any time after my consent is revoked. I may

revoke my consent at any time except to the extent that Applicant or SMUD has already taken action relying upon my consent. If I choose to revoke consent, I will give at least thirty (30) days' written notice to Applicant at the address set forth above. I will also send a courtesy copy of my revocation notice at least thirty (30) days in advance to SMUD at the following address: Sacramento Municipal Utility District, P.O.
