Greenenergy Partner Plus is sold in blocks of 1,000 kilowatt-hours (kWh) or by matching a percentage of your electricity usage (50% and 100%) annually to residential and commercial SMUD customers. The information provided only applies to the portion of your SMUD bill covered by Greenenergy Partner Plus. In 2018, Greenenergy Partner Plus was made up of the following new renewable resources averaged annually.

1. Prospective figures reflect the renewables that we forecast to provide. Actual figures may vary according to resource availability. We will report annually to you in the form of a Historic Product Content Label the actual resource mix of the electricity you purchased. These figures reflect the power delivered to Greenenergy Partner Plus customers in 2018 and the prospective power delivery for 2019.

2. New Renewables come from generation facilities that first began commercial operation within the past 15 years. This product includes generation from a facility that is approved under a strict set of criteria as repowered and has been approved for extended use by Green-e Energy.

Note: At the beginning of 2018, SMUD forecasted to provide Greenenergy Partner Plus customers with a renewable energy product made up of the following mix of resources: 45% biomass, 50% solar, and 5% wind. However, due to regulations set forth by the California Energy Commission, SMUD was required to change this projected mix; as a result, customers of Greenenergy Partner Plus received the following mix of resources in 2018: 4% biomass, 86% solar and 10% wind. This mix change was approved by the Green-e® Governance Board.

* For comparison, the current average mix of resources supplying SMUD in 2016 includes: Eligible Renewable (20% (Biomass 11%, Geothermal 1%, Small Hydroelectric 1%, Solar 3%, Wind 4%)), Coal (0%), Nuclear (0%), Oil (0%), Natural Gas (41%), Large Hydroelectric (23%), and Other (16%).
